e. 3801 Maryland Avenue – Trustee Bazzett presented board with the following ordinance pertaining to public nuisances when complaints are received by clerk:
13.03 ABATEMENT OF PUBLIC NUISANCES.

(1) Inspection of Premises. Whenever complaint is made to the Village President, Health Officer, Village Clerk or Village Board Police Liaison (inspecting officer) that a public nuisance exists within the Village, a notification of possible violation shall be submitted to the Village Clerk. The Village Clerk, Health Officer, Village President or Village Board Police Liaison shall then inspect the property to a reasonable extent and prepare a written report of his findings to the Village President. Whenever practicable, the inspecting officer shall

cause photographs to be made of the premises and shall file the same in the office of the Village Clerk.

The village board gave direction to the clerk to contact source of complaint to get specifics on complaint to and inspect the exterior of the property located at 3801 Maryland Avenue and to file a report with pictures for the boards review. President Wells will contact owners to obtain permission to inspect property.
