#### III. PUBLIC COMMENT

Pursuant to Wisconsin State Statue 19.84(2) "the public notice of a meeting or governmental body may provide for a period of public comment during which the body may receive information from members of the public." Resident Norris Johnson – 3818 Saratoga Court – Pastor of Reconciliation Ministries located at 2200 Mt. Pleasant Street, stated he had received a ticket in the mail for dumping items in the trash dumpsters located behind the Dollar Tree Store. He stated that he had gotten permission from his dumpster company to dump it there. When asked if he had permission from the store owner that rents the dumpster he stated no - he talked to his dumpster company which was the same as the one the store uses. He stated that he has been a good resident of the village and felt that it was unfair that he received the ticket without getting a call. President Wells explained to Mr. Johnson that we are not informed about who the recipients of tickets are and that it is illegal to dump trash in someone else's dumpster without their permission. It was the Dollar Tree that had called the sheriffs dept. on him and reported his license plate number to them. Mr. Johnson became irritated and argued with President Wells. Mr. Johnson also had a disagreement with the representative of Johns Disposal. Sqt. Scyoc of the Racine County Sheriffs Dept. stepped in and explained to Mr. Johnson that the meeting was not the place to discuss the citation, it should have been done at court on the day of the hearing. It had been recorded that Mr. Johnson had not been present for the hearing. Sqt. Scyoc offered to have the case reopened and set for another date.
