Admin Jenkins discussed ways in the future this difference could be used to aid in possible debt obligation payments for increased borrowing for any possible projects the Village would like to address. Motion was made to approve the 2019 Village Budget with adding +\$300.00 to Property Insurance line item and moving \$3,500 from Road Maintenance/Construction line item to Election Wages & Expenses by Rossi, 2<sup>nd</sup> by Rude.
