

- b. President Rossi's Report Gave update on Bldg #2 Repair. Tenant decided they did not want to do the repairs. President Rossi asked that the Village still complete the hallway door installation. Funds were previously approved to cover this cost, and so will move forward.

- h. Trustee Rude Reported existing signage to be used for Dec 2019 Village Street sign approval, thus saving Village ~\$150 in installation costs. Notified the Board of the value of owning the Complex, in spite of the costs to maintain it (netted roughly ~\$94k in 2019). It is very unique to the Village and this Board and Boards that follow should be aware of the revenue it brings the Village. Thanked the previous Board who had the insight to hire an Administrator, specifically Admin Jenkins.
- i. Village Administrator Jenkins' Report Reported end of year fiscal items: New internet plan savings of ~\$50/mo for Office Expenses, online ink subscription to save 5% off ink costs, and a refund of ~\$900 applied for from IRS for possible overpayments of SS/Med costs in 2019. Admin Jenkins then went over 2019 unaudited fiscal report, showing the Village roughly broke even by end of year.
