- A. WHEREAS, the vacant lot at 3406 Elmwood Drive S in the Village (tax parcel ID number 121-03-23-30-090-000)("Property"), is apparently undevelopable due to unavailability of service from the Racine Water Utility and, as such, the owners of the property, Kevin and Laurie Johnson, have expressed interest in having the Village purchase the property;
- B. WHEREAS, Wisconsin law authorizes the Village Board to acquire real property within the Village for parks and other certain improvements dedicated for a public purpose;
- C. WHEREAS, at the Village Board Meeting of December 9, 2021, the Board went into closed session, Wis. Stat. sec. 19.85(1)(e), to discuss and deliberate on a potential purchase of the Property, the purpose for which the Property shall be acquired, and the terms to be offered if said purchase be approved.

RESOLUTION:

NOW THEREFORE BE IT RESOLVED that:

- 1. The Village Board of the Village of Elmwood Park approves a purchase of the vacant property referenced herein (tax parcel ID number 121-03-23-30-090-000) for the purpose of creating and dedicating a Village Park open to the public;
- 2. The Board shall extend to the Johnsons an offer to purchase the property on the terms and for the price approved at the Meeting;
- 3. The Village President has authority to negotiate on the Village's behalf within the range and parameters discussed during the closed session and shall extend an offer to the Johnsons for purchase of the same on the terms and for the price discussed and approved at the meeting; and
- 4. The Village President and Village Administrator/Clerk shall have authority to execute on the Village's behalf all documents necessary to effectuate the purchase and conveyance of the Property to the Village.

It shall be unlawful for any person to carry, possess or use marijuana or synthetic marijuana as those substances are defined in either W.S.A., § 961.01 or have been placed on an emergency schedule by the USDEA administrator, unless such substance was obtained directly from, or pursuant to, a valid prescription or order of a practitioner filled out in the course of his professional practice, or except as otherwise authorized by W.S.A., ch. 961.
